Before you are taken to the payment section you will be asked for a few details as to what prompted your donation, in the field 'What's your reason for giving today?'. Please do let us know so that we can thank you properly, for example 'Collecting tin at work', 'Coffee morning' or 'Sponsored swim' etc.

By phone

You can call us to make a card payment over the phone, on 01494 791224. Please make sure to let us know how you raised your funds, and if Gift Aid can be applied (please see below).

Bank transfer

You can make a payment directly into our bank account, either online or at your local bank. Please make sure to give your name as a reference and if possible some information on how the funds were raised eg Jim Smith, collection at work. **Please contact us by email** (fundraising@cardiomyopathy.org) to let us know that you've made a payment, and so that we can track the funds.

Gift Aid – As if by magic turn every £1 donated into £1.25!

We are able to claim the tax back on donations you make to our charity, so can claim an extra 25% on top of your donation, at no extra cost to you. All you need to do is fill out a Gift Aid Declaration and return it to us with your donation; let us know that we can claim Gift Aid when speaking to us on the phone, or tick the box when donating on our website. When you email us to let us know that you've made a bank transfer please mention Gift Aid, and we will send you out a declaration in the post. You can also complete a declaration online at www.cardiomyopathy.org/giftaid

Please note: we can only claim Gift Aid on personal donations that come direct from an individual. For example, if **you** donated £20 we can claim Gift Aid on it. If you are sending us money that has some from several different people (for example, you have had a cake sale or collected sponsorship for a walk) we are not able to claim Gift Aid on this because it has come from several different people (even if you are sending it to us in one go). In order to be able to claim Gift Aid, we would need a Gift Aid declaration from everyone who has given you a donation for us.
